**Short Stirrup Division:** Open to children 10 years of age and under. To be judged on manners and suitability of mount to rider 50% and equitation of rider 50%.

**Easy Does It Hunter:** Open to all riders. To be judged on manners, performance, suitability, and soundness. May trot or canter fences. Fences 18".

**Pony Hunter:** Open to all ponies. Ponies may be ridden by child, adult, and/or professional. To be judged on manners, suitability, and soundness.

**Hopeful Hunter:** Open to all horses and ponies. To be judged on manners, suitability, and soundness. Fences 2'.

**Schooling Hunter:** Open to all horses. To be judged on manners, suitability, and soundness. Fences 2'6".

**Child/Adult Hunter:** Open to all nonprofessional riders of any age. Will be split under 18 and over 18 if more than 25 riders. To be judged on manners, suitability, and soundness. Riders may choose fences 2'6" or 3'.

**Open Hunter:** Open to all horses and riders. To be judged on manners, suitability, and soundness. Fences 3'

Every entry at a Caves Farm competition shall constitute an agreement and affirmation that all participants (which include, without limitation, the owner, lessee, trainer, manager, agents, rider, handler, and the horse for themselves, their principles, their representatives, employees, and agents: (1) shall be subject to the constitution and rules of Caves Farm and the local rules of the competition; (2) represent that every horse, rider, and handler is eligible as entered; (3) agree to be bound by the constitution and the rules of Caves Farm and the competition, and will accept the decision of the hearing committee on any question arising under said rules, and agree to hold the competition, Caves Farm, their officials, directors and employees harmless for any action; (4) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and hold Caves Farm, the competition, and their officials, directors, employees and their agents harmless from and against all claims including for any injury or loss resulted, directly or indirectly from the negligent acts of omission of the said officials, directors, employees, or agents of Caves Farm, or the competition.
